FOR MODEL: STEALTHTOUCH S-LINE

SHOULD ANY HARDWARE OF MODEL STEALTHTOUCH S-LINE (“PRODUCT”) SUPPLIED BY PIONEER POS SOLUTIONS, INC. (“PIONEERPOS”) PROVE DEFECTIVE BY REASON OF IMPROPER WORKMANSHIP OR MATERIAL AS DETERMINED BY PIONEERPOS WITHIN THIRTY SIX (36) MONTHS FROM THE DATE OF ORIGINAL INVOICE FROM PIONEERPOS, PIONEERPOS WILL, AT ITS SOLE OPTION, REPAIR OR REPLACE THE PRODUCTS (HARDWARE ONLY) IN ACCORDANCE WITH PIONEERPOS’S STANDARD TERMS AND CONDITIONS OF SALE AND RMA (RETURNED MERCHANDISE AUTHORIZATION) POLICY. PIONEERPOS RESERVES THE RIGHT TO AMEND, CHANGE OR OTHERWISE MODIFY ITS STANDARD TERMS AND CONDITIONS OF SALE AND RMA POLICY. THIS WARRANTY STATEMENT DOES NOT COVER OR APPLY TO ADDITIONAL PERIPHERALS OR DEVICES THAT ARE ATTACHED TO THE PRODUCTS, SUCH AS CD-RW DRIVE, DVD DRIVE, MEDIA READER, USB WIRELESS NETWORK, USB HUB, BARCODE LASER SCANNER, PRINTER, OR RECEIPT PRINTER (EXTERNAL.)
